As of October 25, 2024, GBL holds directly and through its subsidiaries 11,820,317 GBL shares representing 8.5% of the issued capital and holds no shares under the liquidity agreement. On that date, 44.3% of the seventh share buyback program is executed<sup>1</sup>.

Following GBL's decision to use the safe harbour<sup>2</sup> regime for the on-the-market share buybacks in the context of a EUR 500 million envelope, the liquidity contract with an independent financial institution has been suspended for an indefinite period.
